Braitheann leibhéal na roinnte agus nádúr a bhfuil roinnte ar chúinsí éagsúla. Bainfidh na forais Rialtais lena roinnimid do chuid sonraí pearsanta úsáid as do chuid sonraí pearsanta ar a gcúiseanna féin (chun eolas atá acu fút cheana féin a dheimhniú srl.) agus d'fhéadfaidís é a chomhshuimiú le heolas eile fút agus faoi do theaghlach atá acu cheana féin. **3. How we use your information and the legal basis**

We use your personal data for purposes including:

**4. With whom do we share your information?**

Aladdin is a secure software as a service application which is owned and run by Cloudware Ltd. (T/A Aladdin Schools), from where the data is only processed for the above purpose.*

**7. How long we hold your data**

*Some personal data is only kept for a short period (e.g. We will destroy at the end of an academic year because it is no longer needed).
